Minutes of the Extraordinary Parish Council Meeting held at Pulham St Mary Church, on Friday 26th July 2024. The meeting commenced at 2.00 pm.

Present: Cllr Scanlan, Cllr Freeman and Cllr Yaxley The Clerk was also in attendance

1. Welcome.

The Chairman, Councillor Scanlan welcomed everyone to the meeting and noted with 3 councillors present, the meeting is quorate and council are permitted to carry out business.

- 2. To consider apologies and reason for absence. Apologies were accepted from Cllr Boardman, McDaniel, Langshaw, Burridge, Hudson and Andersson Hewitt.
- **3.** To consider declaration of interests and dispensation by Councillors No further declarations were required on any matters for consideration.
- 4. To approve minutes of the last meetings of 9th July 2024. Approval of the minutes of 9th July 2024 will be carried forward to the September meeting, along with minutes of this extraordinary meeting.
- **5. Public Forum** *No public were in attendance and a public forum was not required*

6. Items for discussion and ratification

- Amendments to planning application 2022/1353 Land South of Norwich Rd Erect 3 dwellings Objection submitted to original application 22/8/22, Amendments received January 2023, Objection confirmation submitted 24/1/23 New Amendments received 16/7/24 to erect 2 dwellings The Clerk had circulated amendments to all councillors and collated responses under delegated powers, no objections were received and no objections have been received by the Clerk from parishioners. Councillors in attendance confirmed council will support these amendments and the clerk will submit support.
- To consider and ratify request from the village charities for the parish council to support the legal costs for provision of a new lease for South Green recreation ground.
- To consider and ratify legal costs for provision of leases for The Mens Shed and Talent FC If required. Councillors considered estimate of legal costs provided by Spire LLP identifying approximately £1,900.00 plus enquires and searches to provide a 99 year lease for the village charities in favour of the parish council for use of South Green recreation ground, along with the approximate cost to provide 2 x 25 year leases for the parish council in favour of ground users for the approximate total cost of £1,900.00.

Councillors noted an additional cost may be incurred to ensure the recreation ground is formally registered. Councillors are in agreement of supporting the cost to register and provide formal leases, as this will ensure legal compliance of ownership and lease arrangements and will enable to council to support the provision of this asset for community use.

Cllr Yaxley propose up to £5,000.00 to cover the costs identified above, on condition 3 quotes are procured for all transactions and further consideration is given to recovering a proportion of the costs for provision of 25 year leases from leasee's, this was seconded by Cllr Freeman and unanimously agreed.
